

# Yoga Connect Haslett - Kid Room Waiver

## UNSANCTIONED CHILDCARE WAIVER AND HOLD HARMLESS AGREEMENT

PLEASE READ CAREFULLY BEFORE SIGNING

THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS

HASLETT HOT YOGA LLC / YOGA CONNECT HASLETT PROHIBITS ITS STAFF, EMPLOYEES, CONTRACTORS, INSTRUCTORS, OR AGENTS AND REPRESENTATIVES FROM CARING FOR OR PROVIDING SUPERVISION OUTSIDE OF APPROVED YOGA CONNECT HASLETT ACTIVITIES WITH CHILDREN WHOSE PARENT OR GUARDIAN ATTENDS PROGRAMS OR CLASS ACTIVITY SANCTIONED BY YOGA CONNECT HASLETT. THIS POLICY IS DESIGNED FOR THE PROTECTION OF ALL INVOLVED- CHILDREN, STAFF, INSTRUCTORS, PARENTS, AND YOGA CONNECT HASLETT.

This waiver has been prepared to allow for the babysitter's involvement with supervision of a child or children while the parent or guardian participates in an YOGA CONNECT HASLETT sanctioned program or class activity.

PARENTAL APPROVAL SHOULD BE GRANTED ONLY WHEN KNOWLEDGE AND CONSENT APPROVED BABYSITTER SUPERVISION.

Guardian affirms:

I allow \_\_\_\_\_ (the "Babysitter") to provide babysitting or temporary supervision of my child during sanctioned classes or activities. I understand that the supervisory services are not sanctioned by YOGA CONNECT HASLETT but I still desire to engage the babysitter for the service and that by signing below I consent to enter into an agreement with the Babysitter.

I hereby assume all risks associated with having the babysitter provide temporary supervision of my child(ren). I understand that I am to remain on the premises and be immediately available at all times should my child need me for any reason. I understand that YOGA CONNECT Haslett selects and screens its staff, employees, contractors, instructors or agents and representatives for its own sanctioned programs and classes, not child care. I know that Babysitters have not been selected or screened for services related to supervising children. I understand that YOGA CONNECT HASLETT can neither anticipate nor control the situations which may arise as a result of allowing a babysitter to engage with my child(ren).

I understand that the Babysitter is not a representative of nor an agent for YOGA CONNECT Haslett.

I hereby agree to hold harmless, release, defend and indemnify Haslett Hot Yoga LLC/YOGA CONNECT HASLETT, its affiliate organizations and companies, and each of their respective agents, employee, representatives, assigns, officers and directors (each hereinafter a "Released Party" for any and all liability and/or claims for injury or death to persons or damages to property arising from the supervision of my child(ren), including those claims based on any Released Parties alleged or actual negligence or breach of any expressed or implied warranty.

I take full responsibility for any injury or loss myself, my spouse, or child(ren) may suffer arising in whole or part from the supervision of my child(ren). By signing this release, I agree not to sue any Released Party and agree that I, my spouse, or child(ren) are releasing any rights to make a claim or file a lawsuit against any Released Party. I further agree to defend and indemnify each Released Party for any and all claims of myself and/or third party arising in whole or in part from the supervision of my child(ren).

I agree to pay all costs and attorney's fees incurred by any Released Party in defending a claim or suit brought. In the case of a minor in jurisdictions where permitted, I acknowledge that I am also signing this release on behalf of my spouse and child(ren) and they shall be bound by all the terms of this release. Additionally, by signing this release as the parent or legal guardian of a minor, I understand this is waiving certain rights on behalf of my spouse or child(ren) that they may otherwise have.

## YOGA CONNECT HASLETT - KIDS ROOM

### ATTENDANCE REQUIREMENTS

Enrollment forms are available at the front desk of Yoga Connect Haslett and must be completed for each child and returned on or before the first day of attendance. Parents must help us to keep enrollment records current: change of address, name change, and any other relevant information.

### RESERVATIONS & INFORMATION

- An advanced reservation must be made for all children (we sometimes are able to accept same day reservations/walk-ins, but this is not guaranteed) Reservations can be made up to one month in advance and we suggest making your reservations at least 24 hours in advance.
- Reservations can be up to 1 hour per visit
- You must cancel your reservation no less than one hour in advance of the scheduled time. Failure to do so will result in a charge of \$10 to your account, charged to card on file or sent via email invoice.

### CHILDREN UNDER 3

- Please bring diapers, wipes, and a change of clothes along with any comfort item your child may need.
- Spoon fed meals must be given to children before they are dropped off in childcare. Kid's Room staff will give a bottle to infants if needed, but bottle feeding prior to your reservation is encouraged.
- Simple snacks that your child may enjoy are welcome. For example: puffs, dry cereal, etc.

### DIAPERING

- Children must be wearing clean diapers at time of drop off in Kids Room.
- A Kids Room caregiver will check diaper as needed but will NOT be performing any changes. Parent will be notified if change is immediately required.
- If your child is toilet training, we require waterproof training pants or pull ups during their Kids Room visit. Please inform the Caregiver as well if they are potty training.
- Every possible attempt will be made to console crying children. If your child is having a particularly difficult visit and crying inconsolably for more than 10 minutes, we will come get you from the class you are participating in. We will ask you to come and see your child to try and calm them, and if needed sign them out for the day. We will also encourage you to visit again soon!

### CHECK IN / OUT

- The arrival and departure of every child is closely monitored. Parents or guardians must have an active Yoga Connect account.
- Children must be listed on the account and "linked" to parents, our front desk staff will take care of this but ask you to confirm on your end.
- The parent or guardian will check their child(ren) in with a caregiver upon entering Kids Room. The caregiver will access the member account and verify information.

## KIDS ROOM BEHAVIORAL GUIDELINES:

Rules are based upon safety and kindness.

- Children having trouble with self-control will be redirected to another activity.

\*Kids Room Discipline Policy: Children sometimes use physical force or other unacceptable behaviors to communicate. The Yoga Connect Kids Room reserves the right to refuse Kids Room services to children with unmanageable behavior. These behaviors include, but are not limited to the following: biting, kicking, hitting, using profane language, behaviors that endanger themselves or others, or refusal to comply with directives such as thinking time or redirection.

## Essential Health Information for Parents

Please continue to screen your child before bringing them to Kids Room. If your child is experiencing any symptoms, please keep them home until they are symptom free for 24 hours. If we notice your child is experiencing any symptoms during their stay, you will be notified immediately.

Children must be well while attending the Kids Room. Children exhibiting any of the following symptoms are not permitted to attend:

- Pink and/or watery eyes ■ Fever
- Vomiting or diarrhea
- Excessive coughing
- Green and/or excessive nasal discharge ■ Nausea, headaches, or sore throat
- General body aching
- Contagious or unexplained rashes
- If your child has stayed home from school due to illness, they may not attend Kids Room.

Small snacks & water are welcome. Please no nut products or snacks that will cause mess.
